Proper customer completion of the fax cover claim form and appropriate proof of purchase backup will ensure that customers are paid in a timely fashion.

Questions & Answers on the Compaq Cash Rebate

Q1: Which Compaq Workstations are eligible for this promotion?

Compaq is offering a specific online investor configuration of the Deskpro Workstation AP250 through Outpost.com. The three specific part numbers that make up the workstation include:

- 388014-007 (AP250 733 MHz/128MB/9.1GB SCSI/No Graphics)
- 159512-B21 (Matrox G400 Dual Display graphics card)
- 321500-001 (Compaq 56K modem)

The Outpost.com part number that bundles the above three Compaq part numbers is 75897. Outpost.com also has three single part numbers which are bundles of the above AP250 configuration with the three different monitor choices. These are Outpost.com part numbers 75905, 75906 and 75907 respectively for the workstation with the V700, P900, and TFT5000S. See pages 2-3 of this document for more details. Make sure your Outpost.com proof of purchase contains one of these bundle part numbers or the Outpost.com part number for the AP250 and one of the eligible monitors.

Q2: Is it required to purchase a Compaq Monitor, and if so which ones?

The \$200 rebate is only available to those customers that purchase the Deskpro Workstation AP250 with a Compaq Monitor. The eligible Compaq Monitors are the V700, P900 and the TFT5000S (see pages 2-3). Please note that the Matrox G400 Dual graphics card installed in the AP250 will support up to two monitors. So depending on your needs, you may want to purchase a second monitor. In this case your proof of purchase should an Outpost.com part number for a workstation / monitor bundle and also an Outpost.com part number for an additional eligible monitor. If you purchase one of the Outpost.com workstation / monitor bundles and also purchase an additional eligible monitor, Compaq will increase your cash rebate by \$100 to a total of \$300. If instead, you purchase two of the eligible Compaq Monitors with the online investor configuration of Deskpro Workstation AP250 (the standalone workstation without a monitor), Compaq will similarly increase your cash rebate by \$100 to a total of \$300. There will be no additional rebates for more purchases of more than two eligible monitors.

Q3: Do add-on workstation options increase the rebate amount?

No. Depending on your needs, it might be a good idea to consider adding an extra 128 MB of memory or a second hard drive—however, the rebate amount does not increase beyond \$200.

Q4: If I use a firm other than Wall Street Access for my brokerage account, can I still receive the \$200 rebate for a workstation purchase?

This promotion is only available to current and new customers of Wall Street Access with a minimum account balance of \$10,000 (signup between February 18 and May 31, 2000).

Q5: Where can I get further information or assistance regarding the Compaq cash rebate?

Q6: What is the procedure for the customer to get the Compaq cash rebate? This is an afterpurchase cash rebate. Customers must have purchased the online investor configuration of the Deskpro Workstation AP250 and the eligible Compaq Monitor (s) from Outpost.com prior to claiming the cash rebate. Upon completion of purchase, customers call 1-888-927-9366 to receive specific cash rebate instructions. Customers will be faxed or emailed a special fax cover claim form. The fax cover claim form must be completed in order for the cash rebate to be processed. Once completed, it needs to be faxed to 1-800-255-4980 with appropriate Outpost.com proof-of-purchase and Wall Street Access account number documentation. The documentation will be verified and then the check will be processed and mailed to the customer.

Q7: How long after May 31, 2000 do customers have to get the documentation submitted in order to get the rebate check?

Customers have until June 16th, 2000 to get the appropriate documentation submitted to Compaq through the above mentioned procedures. Customers must have proof of purchase between February 18 and May 31, 2000. All claims received after June 16, 2000 will be ineligible for the rebate.

Q8: How many workstation and monitor cash rebates will Compaq issue per Wall Street Access customer?

Compaq will issue \$200 in rebates (or \$300 for dual monitor orders) for every qualifying Deskpro Workstation AP250 combined with an eligible Compaq Monitor purchased by a Wall Street Access customer (retail or institutional). However, increasing the Wall Street Access trading commission credits beyond \$200 is at the discretion of your Wall Street Access representative.

Q9: Can this promotion be combined with any special discount pricing? No, this promotion cannot be combined with any other special Compaq or Wall Street Access pricing or promotional offer.

Q10: Can a Wall Street Access customer purchase any workstation or monitor models other than the Deskpro Workstation AP250 and the Compaq V700, P900 and TFT5000S Monitors and still qualify for the rebate?

At this time the rebate program is limited to the online investor configuration of the Deskpro Workstation AP250 and the Compaq V700, P900 and TFT5000S Monitors available from Outpost.com.

Active Trader Rebates

Wall Street Access has an active trader rebate program, which can reimburse much of the Compaq hardware purchase cost when you generate sufficient commission levels. Specifically, during months that you generate \$450 in equity or \$1200 in option commissions, Wall Street Access will rebate \$150 to your account. You can qualify for up to 24 of these payments. Failing to reach the commission targets during one month does not disqualify you from rebates in future months.
